Law Firm Employees Make Sure Hundreds of Needy Children Will Get Toys This Christmas After Toys for Tots Unable to Meet Demand

WEST PALM BEACH, Florida December 18, 2008- More need and less giving resulted in Toys for Tots not being able to provide the gifts they ordinarily donate to J.A.Y. Ministries inner city youth ministry in Riviera Beach, Florida this year.
